DESCRIPTION:

Chevron Australia is seeking an experienced Contractor with necessary capability, capacity and a demonstrated track-record to supply Mercury Adsorbent (including ceramic balls) and provide support services to support operations. A brief description of each work scope is provided below:

- The supply of products for planned and unplanned events:
 - Supply of pre-sulphided (CuS) Mercury Adsorbent delivered to Chevron's Perth Distribution Centre in Hazelmere, WA; and
 - Supply of Ceramic Balls delivered to Chevron's Perth Distribution Centre in Hazelmere, WA.
- Spares:
 - Contractor shall have own stock holdings of adsorbent
- · Support Services:
 - Provide oversight services on site during loading and unloading
 - Supervise, coordinate and develop written procedures for the transportation, delivery and transfer of Adsorbents from Contractor or approved third party contractor to Chevron's chemical storage facilities and warehouses.
 - Conduct an audit in the plant for all fittings and vessels for compatibility to the bulk Adsorbent supply.
 - Provide onsite written testing procedures to comply with Chevron QA, QC, requirements related to Mercury Adsorbent. Procedures to be reviewed by respective responsible person and kept as ABU authorised and approved procedure.
 - Develop field and laboratory QA, QC and active ingredient residual testing procedures for use in the Laboratory to ensure Mercury Adsorbent are compliant with Chevron and Contractor's requirements.
 - Provide onsite written safe handling and emergency procedures for handling of Mercury Adsorbent. Procedures to be reviewed by respective responsible person and kept as ABU authorised and approved procedure.
 - Provide input to auditing and confirmation that all emergency equipment is on site and fully functional, and if necessary make recommendations for any required improvements.
 - Assist in resolving any onsite problems with the use of Mercury Adsorbent.
 - Provide offsite/onsite training regarding the use of Mercury Adsorbent, including safe handling and emergency procedures.
 - Provide procedure for safe loading and unloading of the Adsorbent

- Provide procedure for start-up/dry out

Disposal

- Dispose or reprocess spent adsorbent
