PACKAGE DESCRIPTION:	<p>Scope will include all management, engineering, supervision, labour, consumable materials, access, construction and demolition equipment, permits, construction aids, tools, services, testing devices, warehousing, supplies, inspections, insurances, communication devices and all other items necessary or required for the proper, safe and timely completion of the Structural Demolition Works.</p> <p>The Contractor is responsible for mobilisation, transport, establishment on Site (excluding accommodation), maintenance and demobilisation of its resources, materials, temporary facilities, plant and equipment and all miscellaneous requirements necessary to perform the work in a safe manner.</p>
SPECIFIC SCOPE REQUIREMENTS:	<p>The Plant Area is located west of the existing ROM pad and generally comprises of steel tanks, structural steel frames, platforms, steel piping, loose waste and an enclosed shed structure.</p> <p>The Contractor must carry out the following key works:</p> <ul style="list-style-type: none">• Safe demolition of the existing tanks, cut into safe handling sections, load and remove off site;• Safe demolition of the existing structural steel frames, piping and platforms, cut into safe handling sections, load and remove off site. <p>The Contractor will carry out its investigations of the Site and the proposed works; including all adjacent areas during the Tender period to which all Site visits and inspections must be coordinated by Covalent. Prior to demolition activities commencing, the Contractor is required to perform pre-sampling assessments of each and every work area utilising the services of a registered Hygienist, of which, all relevant sampling analysis and subsequent procedures for controlling and removal of regulated materials must form part of the Contractors Deconstruction Management Plan (DMP).</p>
