

# Barossa Offshore Project

Title: **Provision of XT Installation and Light-Well Intervention Services for Barossa Development Drilling Campaign**

Scope of Work: Provision of services required to plan and execute XT Installation and Light-Well Intervention for the Barossa subsea wells, located 300 kilometres north of Darwin, Northern Territory, within the Bonaparte Basin in the Timor Sea.

These services shall include, but not be limited to:

- Project management
- Engineering
- Procurement of interface equipment to Barossa XT system
- Supply of a dynamically positioned vessel capable of installation of 60mT tree assemblies and installation and operation of Light-Well Intervention system
- Equipment and personnel supply for all supporting services on the vessel, including vessel operations, intervention package, ROV, wireline/slickline/e-line, etc

1. Wells technical details (subject to change):

- a) 240-260m water depth
- b) 7" x 8.5/8" well completions
- c) 5,600mMD, 4050mTVD (notional)
- d) 3 manifolds, 2 Wells per manifold
- e) 18-3/4-10K H4 hub profile on top of Tubing Head Spool and EVXT
- f) TFMC 7x2-10K EVXT on Tubing Head Spool
- g) Planned barriers in the wells will be 2off wireline plugs, one in the Tubing Hanger and one in a profile above the SCSSV

2. Schedule (subject to change):

- a) Contract Award: Q3 2021
- b) Drilling Rig Start Window: Q2-Q3 2022
- c) XT installation / LWI Window: Q4 2023
- d) URF Installation Window: Starts December 2023

Objectives: The main objectives for this source of interest and information are to:

1. Explore Service Providers ideas or recommendations around XT installation and light-well intervention services; to identify efficiency opportunities, via innovative practices and adoption of innovative technologies.
2. Enable Santos to gather the latest market information on capable Service Providers that conform to the offshore well specifications identified in the scope of work.
