Project Title: Snowy 2.0 – Future Generation Joint Venture

Project Description: Salini Impregilo, Clough and Lane have formed Future Generation Joint Venture (Future Gen) to provide the EPC package for SHL on the Snowy 2.0 Project. The Project is a pumped hydro project that will increase the generation capacity of the Snowy Mountains Scheme by up to 2,000MW and at full capacity will provide approximately 350,000MW/h of energy storage. The project includes all activities associated with the requirements for the Snowy 2.0 Pumped Hydro-electric Scheme.

Opportunity Title: Supply of all Material, Set-up of Production Facility at project site, Transport and Installation of the Project Steel Liners and Penstock

Opportunity Description: Vendor's Scope of Work includes:

- Draft and submission of Shop Drawings and Calculation Reports
- Set-up of a Production Facility fit for purpose and meet AS/ISO 9001:2016 or AS/ISO 3834 standards at the designated Project Area. Following is the key information of project steel lines with approximate details:
 - o Inner Diameter ranging from 2.2Meters to 6.6Meters
 - o Thickness ranging from 20mm to 72mm and
 - o Length of 1km for upstream tunnel steel liners and 0.8km long for downstream tunnel steel liners
 - o 11000 Tonnage for steel lining work
- Mobilization of all and any equipment in order to perform the manufacturing of the steel liners` and penstock elements in full compliance with the Project Requirements
- Implementation of a proper Organization (workmanship, Supervision, Quality and HSE Supervision) to comply with the Project requirements and any other applicable standards
- Procurement and Transport to the of steel plates and accessories to the Project Facility. The Subcontractor shall comply at anytime with all requirements in respect of Traffic Management System as per the regulation in force in Australia during the lifetime of the Contract
- Manufacturing and assembly of penstock and steel lining elements including any required test to fulfill the Contract requirement
- Installation and site operation including the provision of Project Management and Supervision and tools, equipment, systems in order to perform the Subcontract Works in a workmanlike manner
- Technical assistance to the Testing program during all the phases of the execution of the Subcontract Works and final commissioning
- Final dismantling of the production facility and restoring of the area in the original conditions
- Staff and Workers Insurance and Transport of personnel according to Project requirement are at Subcontractor's cost and responsibility

Board and Lodging to be provided by Future Generation (FG JV) and back charged to the Subcontractor.

Requirements:

FG JV requires Subcontractor:

- to provide evidence of similar experience in the Business Industry
- to provide evidence of the required government or industry certifications, licenses, associations and/or insurances to deliver the opportunity
- to comply with all Safety and Environmental Management requirements for the Project. Site Specific Environmental Management Plans will be prepared by FGJV and approved by the NSW Department of Planning, Industry and Environment (DPIE). The Subcontractor must comply with these plans once approved by DPIE;
- to provided evidence that all vehicles need to be fitted with In Vehicle Monitoring System, as per FGJV requirements
- to demonstrate an exemplary safety record and a documented management system for tracking safety performance
- to be financially viable and can demonstrate commercial value
- to demonstrate a strong commitment to training and retaining a local workforce
- to have an excellent track record in employing and progressing the careers of Indigenous people
- to progressively finding ways to develop the careers of women, veterans, and people with disabilities.
- Treat the environmental they are working in with respect and consideration.

General Information:

FG JV will consider all ICN Registrations where:

- The business demonstrates through their response a clear capability against the key requirements
- The business completes a response to all Future Gen questions and/or Future Gen documentation
- The businesses ICN profile is up to date and complete
- The registration is complete prior to any closing date
- The business operates in Australia and is a registered Australian business.
