Cranes, Excavators, Wheel Loaders, Agitator Concrete Trucks, Skid Steers, Backhoes, Graders,

Dozers, Forklifts, Telehandlers, Crusher and Screeners, Prime Movers etc.

- Installation of new Fire Suppression Systems for FGJV plant.
- Supply, disposal and/or recharging of Fire Extinguishers
- Preparation of Fire Risk Assessments and Compliance Testing
- Supply and Delivery of maintenance parts for the Fire Suppression Systems.

An additional 15% of supply shall be provided for Fire Suppression maintenance parts. The

Subcontractor shall be responsible for the supply of tools for activities included within this Scope of

Works. A maintenance plan shall be developed by the Subcontractor and shared with the Contractor,

to manage all FGJV fire suppression systems on site. Note typical maintenance frequencies occur

every six or twelve months.

Personnel mobilisation and demobilisation to be included within the schedule of rates.

The Subcontractor shall also be responsible for the supply of their own Mine Spec Light Vehicles

All vehicles entering site shall be equipped with, at minimum, an In Vehicle Monitoring System

(IVMS), a Mounted Flag Pole, a Rotating Amber Beacon, a Reverse Squawker, and a First Aid Kit.

All works carried out within the Scope of Works shall be conducted in accordance with Australian

Standards. A list of FGJV plant with Fire Suppression Systems currently onsite will be provided during the tender.

Requirements:

FG JV requires Vendor:

- to provide evidence of similar experience in the Business Industry
- to provide evidence of the required government or industry certifications, licenses, associations and/or insurances to deliver the opportunity.
