	Scope of Work The scope of work is for the provision of helicopter services for offshore personnel transfers, including provision of a dedicated operating base (Darwin for Barossa Offshore Project and Northern WA for Dorado) to support 24/7 construction and steady state operations post construction completion.
	Santos is interested in identifying contractors with the capability in one or more of the following scopes: • Drilling and Project Phases for Barossa • Drilling and Project Phases for Dorado • Operations Phase for Barossa • Operations Phase for Dorado • Exploration Wells
	The scopes may be awarded to one or multiple contractors.
	Drilling and Project Phases
	During the drilling and project phases, services will be delivered to several offshore vessels and Floating Production Storage Offtake vessel (FPSO) hook up and commissioning for Barossa and Wellhead Platform and Jack-Up Rig for Dorado.
	Vessels will be located in the Barossa site footprint approximately 300km (161 Nautical Miles) offshore north of Darwin, Northern Territory, located in the Timor Sea.
	Vessels will be located in the Dorado site footprint approximately 150km (78 Nautical Miles) offshore north of Port Hedland / 275km (148 Nautical Miles) offshore north-west of Karratha, Western Australia.
