Title:	International Freight Forwarding and Customs Brokerage Services
Scope of Work:	The Logistics Service Provider (LSP) will operate an existing world-wide transportation and Freight Forwarding network offering air and sea cargo shipping services with up-to-date SKU / product line level tracking, alerting and KPI reporting systems. The LSP will provide all Freight Forwarding and Customs Brokerage Services necessary to export cargo from origins all over the world, and to facilitate clearance and release of cargo through the Australian Border from the various sea and airports within Australia for the Project. The LSP will execute two primary logistics functions for the project as follows:
	1) International Freight Forwarding (Multimodal) The LSP will provide all labour and equipment to provide International Freight Forwarding and Customs Brokerage Services necessary to transport equipment and materials from various suppliers and facilities located throughout the world for the project. The equipment and materials will be transported by the LSP via various modes (sea freight predominantly, air, road and rail additionally) and deliver directly to the Pluto Train 2 Jobsite or other destinations as instructed.
	2) Customs Brokerage The LSP will provide all labour and equipment to provide Customs Brokerage Services necessary to support the export of project cargo from origins all over the world, and to facilitate clearance and release of cargo through the Australian Border from the various sea and airports within Australia.
	The LSP will have responsibility to:
	<ul> <li>Provide suitable personnel and equipment to load/unload, handle, store and transport project equipment and materials while conforming to all relevant International, Federal, State or Territory law.</li> <li>Obtain any necessary permits/passes required for air/road/rail transport, port, and airport access and for access to Pluto Train 2 Jobsite.</li> <li>When necessary, provide specialized equipment for cargo with oversize, over-mass, soft ride, or temperature control requirements.</li> <li>Provide escort vehicles for all oversize or over-mass loads in accordance with the MRWA Pilot Vehicles and Pilots Code of Conduct.</li> <li>Receive/verify weights and number of packages received from Project suppliers.</li> </ul>

• Highlight any discrepancies when packages are received from Project suppliers which are either incomplete or whose packaging is insufficient to ensure safe transport to Project jobsite. Provide a daily report in the required format (electronic – to be confirmed). Maintaining and enforcing Project's Safety Philosophy whilst adhering to all Site Safety Rules and Regulations while on Jobsite. The LSP will need to Demonstrate this with existing safety records. Supply all timber, dunnage, packing and securing material that is required to safely transport equipment to Jobsite. Provide suitable personnel and equipment for transportation, handling, and storage of Dangerous Goods, complying with Australian Dangerous Goods Code (ADG Code), and all other relevant International, Federal, State or Territory law.
