ICN invites Expressions of Interest from potential contractors that have the capability and capacity to perform the following package of work as part of the Aurukun Bauxite Project.

PACKAGE TITLE: SITE SECURITY SERVICES

All EOI submissions should be made through the ICN Gateway.

Scope of Works

The Project requires a contractor for provision of professional licensed security services to support the Project site including accommodation and recreational areas.

The scope of works will cover two phases:

Construction period of approximately 24 months including a 450 bed construction camp.

Ongoing operations post construction period including a workforce of 480 and Accommodation Village housing 280 beds The Scope of Works for this package includes:

- Recruitment of Local Workforce Participants with appropriate qualifications that are available within the project construction workforce pool
- Conduct site visitor inductions for all site visitors.
- Issue and maintain site identification tags
- Provision of a site access control service to the construction camp and accommodation village during the construction phase
- Provision of vehicles to undertake regular perimeter and asset specific patrols as required
- Management/recording of ingress, egress of employees, contractors, visitors and other personnel and materials delivered to the site
- Ensure that visitor/contractor/other personnel entry to the site are in line with Company access and induction requirements
- Manage escort of visitors and deliveries as required
- Undertake bag and vehicle searches as required under Project polices/procedures to identify restricted, unauthorised or prohibited items
- Monitor site VSS (CCTV), emergency calls and respond in accordance with the site Emergency Response Plan
- Undertake daily, weekly and monthly reporting as agreed with the Project Proponent
- Liaise with Royal Flying Doctor Service (RFDS), Queensland Police Service (QPS) and Queensland Fire and Rescue Service (QFRS) where required for emergency medical evacuations
- Liaise with on site Paramedic and Rescue Services provider

	<p>The selected Contractor shall provide all management, training, supervision, labour, specified equipment, including all furnishings, tools, consumables and operating supplies, materials and incidentals, and perform all necessary operations required for the Scope of Works generally described above.</p> <p>The selected contractor shall provide all security personnel with appropriate uniforms and PPE required to perform necessary operations in accordance with site requirements.</p> <p>The Project Proponent shall provide workforce transportation from Cairns, via Aurukun to site, and accommodation on site as well as diesel, a concrete batch plant and site security.</p> <p>Glencore is a signatory to and active participant in the Voluntary Principles on Security and Human Rights (VP's). Glencore is committed to the continued implementation of the VP's and contractual provisions will detail our expectations that all Contractor employees will complete awareness training on Glencore's commitments to Human Rights including the principles of de-escalation and the use of force and weapons.</p>
Project Description	<p>The Aurukun Bauxite Project ("the Project") involves the construction of a new bauxite mine north of Aurukun on western Cape York Peninsula in Queensland, Australia. The Project is located on the land of the Wik and Wik Waya People.</p> <p>The Project Proponent is the Aurukun Bauxite Project Joint Venture, a joint venture between Glencore Bauxite Resources Pty Ltd and MDP Bauxite Pty Ltd, a Mitsubishi Corporation entity.</p> <p>The Project is managed by Aurukun Bauxite Management Pty Ltd, a Glencore entity, as agent for and on behalf of the joint venture participants.</p> <p>In 2021-22, the Project intends to proceed through agreement and approval processes, as well as a technical program, that will inform a final investment decision.</p> <p>Any procurement decisions are subject to approval of the joint venture participants.</p> <p>More information about the Project can be found at www.aurukunbauxite.com.au.</p>
Location	<p>The Project is located approximately 800km northwest of Cairns and 160km to the south of Weipa (by road).</p> <p>The Project site consists of three zones, which include the following facilities:</p> <ul style="list-style-type: none"> • Eastern Zone – Mine Administration Area, Accommodation Village, and Construction Camp; • Central Zone – Mine Infrastructure Area, Beneficiation Plant, Fines Containment Area, Process Water Pond and Tapplebang Dam. • Western Zone – Product Haul Road, Coastal Materials Handling Facility and Marine Facility <p>This Scope of Works is to be performed: Eastern Zone, Central Zone, and Western Zone.</p>
Delivery Schedule	<p>The Scope of Works in this package are anticipated to commence in 2023 subject to investment and regulatory approvals.</p>
