 Widening of approximately 30km of existing bituminised surface from 6.5mtrs to 8mtrs along Parker Range Road.

 Upgrade of approximately 21km of an existing gravel section of road to a bituminised sealed surface along Parker Range Road

through to Marvel Loch / Forrestania intersection.

 Upgrade of approximately 61km of an existing gravel section of road to a bituminised sealed surface from the intersection of Parker Range Road - Marvel Loch / Forrestania through to Mt

the Covalent Lithium Holland Mine Site turn in.

Works may include some minor road alignment changes.
