Mt Holland Lithium Project

PROJECT OVERVIEW:	Covalent Lithium is developing, and will operate, the Mt Holland Lithium Project which will include the construction and operation of a fully integrated mine, concentrator, and refinery in Western Australia.
	The Mount Holland Site is approximately 500km east of Perth and 120km South of Southern Cross in Western Australia.
PACKAGE TITLE:	Mt Holland Supply and Delivery of Bulk Diesel Fuel
PACKAGE REFERENCE:	CON-182
PACKAGE DESCRIPTION:	Covalent Lithium invites expressions of interest (EOI) from contractors experienced in the provision of supply and delivery of bulk diesel fuel.
SPECIFIC SCOPE REQUIREMENTS:	Provision of supply and delivery of diesel fuel to the Mt Holland Mine Site, situated approximately 500km east of Perth and 120km South of Southern Cross in Western Australia.
	• Current fuel consumptions vary between the 400-630kL range during the site construction phase. Once construction activities taper off and Covalent moves to mains power in November 2022, the fuel consumption is expected to site around the 600kL per month.
	• The Fuel Facility will be constructed by the Company's Mining Services Contractor. The estimated construction timeline is September 2022 to January 2023.
	• The Fuel Facility shall provide a 24-hour, year-round safe and efficient refuelling area for equipment on site. The Fuel Facility shall be utilised by the Principal and others on site.
	• The fuel facility estimated total footprint space requirement - 30m wide and 30m long with a nominal 220KI Diesel storage with option to expand to 330KI. There will be one heavy vehicle dispensing on concrete with a loading arm, 800 litres per minute high flow using dry-break nozzles. The unloading area, with receiving manifold, will be designed for one (1) B-Double tanker. The application is for fuelling haul trucks and wheeled equipment.
