## WMP-CON-640 Supply of Concrete Installation (Civil)

### Procurement Route

OZ Minerals Musgrave Operations Pty Ltd requires the supply of Concrete Installation (Civil) for the Minerals Processing Plant from suitably experienced and qualified vendors for the West Musgrave Project.

### Requirement / Scope of Works

OZ Minerals is seeking expressions of interest (EOI) from Experienced Contractors who can undertake large scale civil packages in excess of 10,000m<sup>3</sup> of concrete at the OZ Minerals West Musgrave Project located in Western Australia.

The Scope of Works includes, but is not limited to, the supply of labour, tools, construction plant, plant operators, equipment, supply, and installation all reinforcement bar and mesh (including bending and fabrication), supply installation of chairs, spacers, hangers etc. Provision of screeding equipment, formwork/falsework, consumables, testing devices, etc. Concrete installation includes compaction, concrete finishing, curing and protection, forming construction joints and treating the set concrete.

The concrete supply (by others) comprises of:

- N15 Blinding Concrete;
- N32 Structural Grade;
- S40 Structural Grade (60% Caltite).

### Next Steps

On the receipt of EOIs, OZ Minerals will review and on short-listing, formally advise each successful contractor/supplier that they will be invited to participate in a formal Contract Tender process (RFT).

OZ Minerals will publish Request for Tender (RFT) documents to successful contractor/ suppliers in August 2022.

The West Musgrave Project is subject to internal OZ Minerals and external approvals. A final investment decision is expected in 2022. Consequently, timing, procurement strategy and/or scope of works, may change at the discretion of OZ Minerals.

### Submission of Expression of Interest (EOI)

OZ Minerals invites capable and experienced Contractor/Suppliers, who align with our 'OZ Way' of working to register their EOI, clearly identifying their capability to be execute the scope herein. OZ Minerals will use the EOIs to improve our understanding of market capability and interest.
