Scope

Score Australasia Pty Ltd under contract from BAE Systems Australia Ltd is seeking Expressions of Interest from Australian Industry in order to supply valves and associated equipment to BAE and ASC Shipbuilding Pty Ltd for the Hunter Class Frigate Program (HCFP).

The Hunter Class Frigates will be built at the ASC Shipbuilding Facility at Osborne, Adelaide, SA, and will require maximisation of local content in Australia.

As a result, Score are seeking EOI from Australian based companies with manufacturing capability, which may enable them to become future suppliers or form part of an Australian based supply chain. The scope of the proposed work package is outlined below.

A pre-qualification questionnaire forms part of this document and will be used to determine industry capability and the viability of a partnering arrangement to provide valves and associated equipment to the HCFP.

Suppliers will be required to supply valves to the below specifications:

- The scope of supply is for various types and sizes of Rubber Lined Butterfly Valves for use on the HCFP
 - o Quantity: ≈700
 - o Size Range: DN80-500
 - Pressure Class: PN16
 - End Connection: Wafer & Lugged
 - o Body Material: Stainless Steel & Nickel Aluminium Bronze
 - o Actuation: Gearbox, Hand Lever & Bare Stem
