	(e)	medical treatment and assistance;
	(f)	effective communication between the person authorised to coordinate the Emergency response and all people at Site;
	(g)	testing of the Emergency procedures, including the frequency of testings; and information, training, and instruction to relevant personnel in relation to implementing the Emergency procedures
