The scope(s) of these services is applicable to all areas of operations, with the base located at the Companies Distribution hub at Vale Street Hazelmere Western Australia and will include but not be limited to:

- Mainland Road Linehaul Transport
- Mainland Local Couriers and Transport
- Mainland Air Freight Services (excludes Barrow Island)
- Third Party Services

The Scope of Work is for the provision of mainland transportation services as required by Company and includes, but is not limited to the following work activities:

- Provision and management of all personnel, equipment, tools, materials and technical expertise to perform the requirements detailed in this Scope.
- Capacity, equipment and infrastructure to service a wide range of freight categories, including Line Haul, Local transport PUD, Couriers which will deliver an, efficient and reliable integrated logistics solution.
- Carriage of large volumes of perishable and temperature sensitive cargoes under the HACCP standard.
- Registered provider for the movement and handling of all classes of dangerous goods across its networks.
- Facilitate the ad-hoc third party purchase of certain materials, out of scope services to meet requirements with respect to, or in relation to, the performance of services under this contract (s).

- Provision of technology that will support automated booking, proof of delivery, track and trace of consignments and assets, with the ability to provide transparent standardised weekly operational reports.

In addition, Company requires all potential bidders to have a majority of Company owned and operated fleet and assets to support its business.

Preference will be given to applicants who operate an active Australian Industry Participation process to promote the use of Pilbara, other Western Australian, other Australian and aboriginal employment and participation

The proposed term of initial contract is 5 years commencing April 2015
