

<p><b>Project Overview:</b></p>	<p>IB Operations Pty Ltd (<b>IB Operations</b>), as agent for the joint venture between FMG Magnetite Pty Ltd and Formosa Steel IB Pty Ltd, is developing a new magnetite mine and associated infrastructure at its Iron Bridge site (<b>Iron Bridge Magnetite Project</b>).</p> <p>The Iron Bridge site comprises the North Star, Eastern Limb, Glacier Valley and West Star magnetite iron ore deposits located in the Pilbara region of Western Australia.</p> <p>The Iron Bridge Magnetite Project will include the execution of a process plant, non-process infrastructure, a slurry and return water pipelines, a raw water pipeline and port infrastructure to support 22 wmtpa production.</p> <p>To support FMG’s Decarbonisation strategy and achieve net-zero emissions, there is a requirement for the electrification of mining equipment and other assets across all operations (<b>Decarbonisation Electrical Infrastructure Project</b>).</p> <p>Overhead lines, transformers, switchgear, ring main units (RMU), and associated electrical services are required to expand FMG’s electrical distribution network across brownfield operations.</p> <p>Projects will be packaged into programs of work, dependent on-site requirements.</p>

The scope may change at FMG’s election, including to accommodate project budget and time requirements.</p>
