<b>2. INDICATIVE SCOPE OF WORK</b>	
<b>Package Description</b>	<p><b>Overview</b></p> <p>Saipem Australia Pty Ltd and Clough Projects Australia Pty Ltd Joint Venture (herein referred to as the "CONTRACTOR") has reached an agreement with Perdaman Chemicals and Fertilisers Pty Ltd (herein referred to as the "OWNER") for the Engineering, Procurement, Construction and Commissioning of the Burrup Urea PROJECT located in the Burrup Strategic Industrial Area, Burrup Peninsula, Western Australia.</p> <p>Perdaman Chemicals and Fertilisers Pty Ltd (OWNER) is focused on the development of Perdaman - Project CERES which shall be the world's largest gas stream ammonia-urea plant with a production capacity of 2.14 MMTPA granular urea.</p>

PERDAMAN PROJECT has been designed as a modularised Project with pre-assembled modules to be transported from yard to site. However, few of the preassembled modules will be delivered to site near to the foundation and lifted/ installed using crawler cranes. Moreover, there are over sized/ over weight Equipment that needs to be Lifted/ installed at site such as Reactors, vessels, Converters, Columns, Towers, Exchangers, CO2 absorber, Strippers, etc.

**General Scope of Supply / Services**

The purpose of this document is to specify the general requirements for the Heavy Lift works based on the crane requirement presented in the indicative SOW.

SUBCONTRACTOR shall refer to Crane utilization histogram presented in this document. Subcontractor shall (unless otherwise noted) provide all supervision, labour, sub-subcontracting, equipment, cranes, tools, consumables, supplies, and all other things required for the completion of the Work.

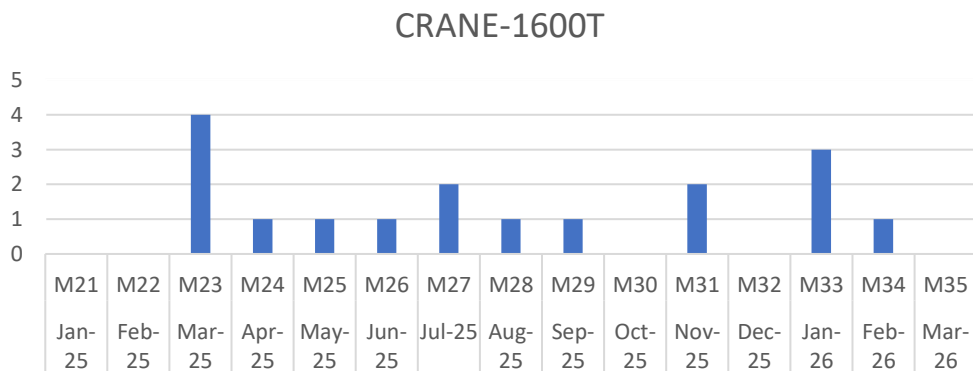
A detailed SOW will be provided to the short-listed subcontracts prior to bidding stage.

Design, supply, construction shall comply with the applicable and up-to-dated version of local, national, regulatory, and statutory Requirements, Codes, Standards, Contract, Specification, Drawings and Tender Package documents.


As per the project requirements for the heavy lift Package award to SUBCONTRACTOR, **1600T** crane capacity is required for the installation of OS/OW modules and equipment such as **Demag CC8800** OR Equivalent. In addition to a **700T** capacity crawler crane such as **MANITOWOC MLC650** OR Equivalent. The required hiring periods as project requirements are indicated below.
