DESCRIPTION:

Chevron Australia is seeking expressions of interest from capable Service Providers with a demonstrated capability in providing personnel and equipment services at four of the Company's sites in support of Company operations in Western Australia for the scope identified below. The sites are the Perth Distribution Centre in Hazelmere, the Wheatstone warehouse at Ashburton North, the Gorgon warehouses on Barrow Island and the WA Oil warehouse on Barrow Island.

Expressions of interest are being sought to enable Chevron to refine a Bidders list to include in a Request For Proposal (RFP).

The Company wishes to enter into a Master Services Agreement with the successful Bidder and utilise a Service Order for the individual sites with a term of approximately 5 years.

The requirement for the Services scope of work across all sites will include but not be limited to:

- Receipt, QA/QC, store, preserve, stocktake, pick, pack, issue, consign and dispatch all materials and equipment required to support Chevron operations;
- Handling and storage of Dangerous Goods;
- Quarantine remediation and preparation of materials;
- Manage returns, repairables and disposals;
- Use of material management systems and barcoding technology;
- Stuffing, destuffing and handling of containers and other shipping assets within the facility;
- Pick up and delivery of materials to plant drop points or within the local area;
- Provide after hours support to operations as and when required;
- Operate under Contractor Management Systems (HSE, Operations, Quality, Quarantine (where applicable) etc.) in line with Company standards;
- Provide sufficient equipment and labour to support the operating hours of each facility;
- Washpad operations (asset cleaning/quarantine remediation);
- Staging of materials for maintenance activities;
- Loading and unloading trucks and trailers to / from local, interstate and North West locations as applicable.

The requirement for the Services scope of work at the Perth Distribution Centre in addition to the above will include, but not be limited to:

- Providing Quarantine Compliant operations in support of Company Barrow Island and Thevenard operations; and
- Providing cross dock services primarily in support of WA Oil and Drilling and Completions operations.

Hours of operating will differ between the sites with Barrow Island requiring a non-construction rostered FIFO workforce 7 days a week. Perth Distribution Centre and Wheatstone POF Warehouse hours will be described in the RFP.

The facilities will be provided by Chevron at:

- Chevron Perth Distribution Centre located at Hazelmere, WA;
- Wheatstone Operations Warehouse, Ashburton North;
- Gorgon Permanent Operating Facility and Construction Warehouses, Barrow Island, and
- WA Oil Operating Warehouse, Barrow Island.
