ASC is seeking Expressions of Interest (EOI) from companies with the capacity and capability to supply crane hire services to ASC in support the Collins Class Submarines (CCSM).

## Scope of work

Supply on-going contracted services to support planned, un-planned & urgent maintenance. In support of crane hire services as per type of minimum capacity, standard daily 50T/60T lifts, can include 100T lifts at times and adhoc crane support. 25T franna and 40T franna. Include provisions to provide wet and dry hire.

#### Requirements

- Schedule of rates to support crane hire services as per type of minimum capacity.
- Include provisions to provide wet and dry hire rates.
- Supply suitably qualified operators and riggers for machine/s and/or vehicles supplied.
- Hold appropriate licenses.
- Appropriately maintain machines and vehicles.
- All crane hire activities, including but not limited to, lifting, lift and carry, equipment and crane travel to be in accordance with relevant Australian Standards (AS 1418.5-2013 and AS 2550.5-2022).
- Ordinary working hours between 7:00am and 4:00pm and be available for overtime, weekend and public holidays support.

- Common User Facility, Henderson, WA.

- Submit a schedule of rates for supply of Crane & Operator Services.
- A high level overview of personnel experience relating to the services.
- Hold all licences and relevant insurances.
- Defence Industry Security Program (DISP) membership details (if applicable);
