The Formwork shall be used to produce the precast columns and beams in accordance the requirements given in this document and its annexes. Without formwork surface rusting or deformaties, bulging, deflection, out of level, alignment and orientation. Total 4 rows with length of 36.5 meters moulds are required. However, subcontractor can recommend lengths of moulds that fit the puspose.

Fit to purpose Designing, fabrication and supply of formwork moulds along with surface vibrator arrangement ( with the control system) to be



designed and supplied along with the moulds by the subcontractor to ensure proper and uniform compaction of the concrete as per the requirements.

The Number and capacity/frequency of surface vibrator shall be designed and provided by subcontractor based on surface plate thickness and structural supporting frames.

The subcontractor shall commission and test the moulds under the surveillance of the Contractor before completing the work. The scope of Work shall also include a training provided for the personnel of the Contractor on the safe and successful operation and maintenance of the Moulds.
