

Project Overview:	<p>IB Operations Pty Ltd (IB Operations), as agent for the joint venture between FMG Magnetite Pty Ltd and Formosa Steel IB Pty Ltd, is developing a new magnetite mine and associated infrastructure at its Iron Bridge site (Iron Bridge Magnetite Project).</p> <p>The Iron Bridge site comprises the North Star, Eastern Limb, Glacier Valley and West Star magnetite iron ore deposits located in the Pilbara region of Western Australia.</p> <p>The Iron Bridge Magnetite Project will include the execution of a process plant, non-process infrastructure, a slurry and return water pipelines, a raw water pipeline and port infrastructure to support 22 wmtpa production.</p>

Package Description:	<p>At the time of publishing this invitation to register an interest, the Services include providing the skilled personnel and equipment to undertake Pipeline Maintenance and Repair Services for the pipeline network including the following pipeline systems:</p> <p>The overland pipelines include:</p> <ul style="list-style-type: none"> • 160km Canning Basin Raw Water Pipeline System from Shay Gap Pump Station to Iron Bridge OPF (Ore Processing Facility); • 135km Concentrate pipeline from Iron Bridge OPF to Iron Bridge CHF (Concentrate Handling Facility); • 135km Return water pipeline from Iron Bridge CHF (Concentrate Handling Facility) to Iron Bridge OPF; • 9km Tailings Pipeline from Iron Bridge OPF to Iron Bridge TSF (Tailings Storage Facility), this is in the vicinity of the Iron Bridge OPF; • 8km Decant return water pipeline from Iron Bridge TSF Decant Pond to the Iron Bridge OPF, this is also located in the vicinity of the Iron Bridge OPF area; and • 52km Bore Field Pipeline System from the 10 abstraction production bores to Shay Gap Pump Station. <p>Pipeline Maintenance and Repair Services are envisaged to be carried out on site on a continuous basis.</p> <p>The Services include but are not limited to the following tasks:</p> <ol style="list-style-type: none"> 1. Attendance at risk assessment workshops. 2. Site establishment, mobilisation of Contractor’s Personnel, Contractor’s Equipment and Contractor supplied Plant and Materials. 3. Providing pipeline repair services including the provision of all associated equipment necessary to undertake the pipeline repair services and, carrying out the pipeline repair services; including: <ol style="list-style-type: none"> a. Safe excavation at the repair location. b. Cutting out and removing the existing pipework or coupling to be repaired; c. Installing a new, replacement mechanical coupling only or; d. Installing new pipework with two mechanical couplings; and then e. Backfilling the area as per Iron Bridge Operations specifications.

	<p>4. Providing engineering services to perform follow up analysis or propose remediation methods.</p> <p>5. Creating a pipeline repair operating procedure.</p> <p>The commencement date for the Services is expected to be the 1st of May 2024.</p> <p>Consumables, fuel, water, accommodation, and flights to and from site will be provided by Iron Bridge Operations.</p> <p>The Iron Bridge Magnetite Project, including this package IB24OP031 (A) is subject to internal approvals. The procurement process or scope may change at IB Operations’ election, including to accommodate project budget and time requirements.</p>
