2. SCOPE

The scope of this particular EOI covers all supply categories related to Maintenance, Repairs and Operations (MRO).

3. CATEGORIES

The types of goods and/or services that may be needed are as follows;

Category	Description
Calibration Equipment	Provision of calibration equipment including but not limited to, gas, heat and temperature, pressure, electrical, weighing and mass, metrology, to meet required Australian or International (ISO) equivalent accredited standards and regulations
Calibration Services	Provision of calibration services including but not limited to covering calibration of gas detection, heat and temperature, pressure and level, temperature, electrical, weighing and mass to meet required Australian or International (ISO) equivalent accreditation standards and regulations
Industrial Gases	Provision of various industrial gases including Liquid Nitrogen, Oxygen, Oxygen Acetylene, Butane, Propane, Ammonia, Argon, Helium and other industrial gases
Lifting Equipment	Provision of equipment for lifting and lowering loads, and includes any accessories used in doing so to support, fix or anchor the equipment. This may include Harnesses, Ropes, Chains, Beams, Slings, Shackles, Load Restraints, Hooks, and other lifting or lowering apparatus
Material Handling Equipment	Provision of mechanical equipment used for the movement, storage, control and protection of materials, goods and products throughout the process of manufacturing, distribution, consumption and disposal. The different types of handling equipment can be classified into four major categories: transport equipment, positioning equipment, unit load formation equipment, and storage equipment.

Helmets, Goggles, Glasses, Boots, Ear Plugs, Face Masks, Respirators - Antistatic Products ie. Coats, Earth Straps - Field Support clothing and equipment ie. Test Equipment	<p>Provision of equipment that performs tests on a device which requires interpretation of results ie. Thermal, Electrical, Electronic, Cable, Data Logger, Environmental, Industrial, Chemical, Nuclear</p> <p>This may be provided in a form of purchase or hire agreement.</p>
Tooling	<p>Provision of various small machines, hand held tools, or apparatus of plant and machinery:</p> <ul style="list-style-type: none"> - Cutting and Forming Tools ie. Boring, Milling, Inserts, Drilling, Reaming - Tooling machine - Tooling Metalwork - Power Tools ie. Drills, Grinders, Polishers, Sanders, Planers, Nibblers, Shears, Saws, Air Tools, Spray Gun - General use tools ie. Screwdrivers, Spanners, Hammers, Clamps, Vices, Mallets, Hex Keys, Bevels, Punches, Scribes, Sockets, Wrenches - Jigs and other attachments - Cutting, Drilling or Reaming ie. Drill Bits, Knives, Cutters, Chisels, Tap, Dies, Reamers, Snips, Shears, Punch, Saw Blades
