	Additional Background Information on BWI Operations
	The medical service will be over-sighted by the Chevron Lead Medic located onsite, who will provide the interface between the contractor and the multiple stakeholders on BWI.
	The main medical centre currently sees approximately 100 cases per day. The cases range from primary care issues to the acute trauma and medical issues that require immediate care. BWI is supported with evacuation of acute care patients through the West Australian Resources AeroMedical Evacuation Service (WARAME) contract, which includes an Aeromedical Evacuation (AME) team and jet located in Karratha for evacuation of patients requiring transfer for definitive care and ongoing inpatient management. As the project transitions to operations and steady state, medical service responsibilities will also alter and there will be requirements for on-site case management, screening and surveillance of the various work place and potential environmental issues. (See above break-down of the medical service requirements). Skill mix of staff will need to be flexible during the contract life as the work transitions on BWI. For example, currently there are some 8,500 people working on BWI, which requires a number of medical practitioners to provide the necessary clinical services, but as numbers of persons on the island reduce so will the number of medical practitioners, hence skill mix will change.
