TITLE: C1322631 – Security Services

DESCRIPTION: Chevron has a requirement for the provision of Security Services for Company's Perth Based operations and in concert with the Gorgon and Wheatstone Assets.

Company seeks a Contractor to provide experienced licensed security guards to undertake monitoring and guarding services for Company's respective operations.

The preference is to have one Contractor who is able to provide security guards for all three locations. The Contractor would be required to provide a core crew of security guards 24/7 and to be able to provide additional guards during other higher risk times e.g. maintenance periods, elevated threat levels etc.

The key roles and responsibilities undertaken would include (during steady state operations);

- Permanent security guard presence;
- Monitoring emergency phone and radio calls and activating the onsite emergency response arrangements;
- Monitoring and operating the appointed security monitoring systems;
- Searching of personnel, vehicles, equipment, baggage or materials entering/leaving the LNG Plant and port facility;
- Conducting regular security patrols;
- Monitoring and responding to a security incident;
- Physical security presence at port facility (as required); and,
- Preparation of security incident reports and investigations.

To effectively contribute to achieving maritime security outcomes it would be also advantageous if the Contractor could also provide a portion of qualified Maritime Security Guards (MSGs) on a as needs basis. MSGs perform a range of roles, including but not limited to:

- Access control;
- Controlling embarkation of people, baggage and cargo;
- Monitoring of restricted areas (including Maritime Security Zones);
- Provision of security services including patrols;
- Supervision of cargo and ship stores;
- Screening passengers, baggage and cargo;
- Checking of documentation (including identity documents); and
- Monitoring of closed circuit television.

During maintenance schedules and other periods where there are large numbers of contractors there will be an additional requirement to increase the security guard force number to undertake additional roles such as:

- Physical presence on access/egress points;
- Physical presence in camp; and

- Augmented security patrols.

Inclusive to the aforementioned there are other routine security activities as directed by the company.

Chevron and Regulatory Considerations:

Chevron abides by the “Voluntary Principles on Security and Human Rights” charter and accordingly expects that any contracted security provider observe the policies of the Company regarding ethical conduct and human rights in the delivery of their security services.

The security contractor is required to comply with the WA Security and Related Activities (Control) Act 1996 and accompanying Regulations.
