TITLE: EOI 28 Quarantine Treatment Services (Third Party)

DESCRIPTION: An Expression of Interest (EOI) is sought from industry to undertake quarantine treatment services in accordance with the Barrow Island (BWI) Terrestrial and Marine Quarantine Management System (QMS).

Businesses assessed as meeting the requirements in terms of facility, infrastructure, internal systems and organisational capability will be held on a list of Barrow Island preferred quarantine service providers to be issued to existing and new contractors and vendors seeking these services.

The QMS governs all materials, personnel, vessels and aircraft travelling to, or transferring via BWI, or the surrounding waters. The specific objectives of the QMS are to:

- Prevent the introduction of Non-indigenous Terrestrial Species and Marine Pests;
- Detect Non-indigenous Terrestrial Species and Marine Pests;
- Control and, unless otherwise determined, eradicate detected Non-indigenous Terrestrial Species and Marine Pests;
- Mitigate adverse impacts of any control and eradication actions on indigenous species taken against detected Non-indigenous Terrestrial Species and Marine Pests;
- The QMS comprises guidelines, procedures, standards and checklists organised within a hierarchical structure, with each tier of documents supporting the one preceding it.

An EOI is sought from licensed pest control company's demonstrating infrastructure, internal systems (processes and procedures) and organisational capability to undertake quarantine treatment services on general cargo, including containerised or crated equipment/materials, skid, steel or loose equipment, plant or mobile equipment (complex and non-complex), air freight and special and sensitive equipment destined for Barrow Island. The services will be performed at off-site contractor premises in Perth and Karratha. The services to be provided may include the following:

- Application of residual insecticide treatment in accordance with the APVMA (Australian Pesticides and Veterinary Medicines Authority) approved product label;
- Application of one-shot and knockdown insecticide dispensers;
- Installation of rodent bait stations to enclosed cargo;
- Molluscicide treatments;
- Application of pestigas treatment to enclosed cargo;
- Fumigation treatments (e.g. Sulphuryl Fluoride);
- Pest and weed control treatments to off-site facilities;

	 Other targeted treatments to address risks in particular locations; Documentation to support the above activities (e.g. Treatment Certificates).
	 Applicants will be required to provide information addressing the following criteria: Details of licensed personnel; Details of equipment to provide the above services; Details of in-house training programs and Verification of Competency programs; Record management; Experience providing pest control services for Barrow Island equipment.
